11. Change of match structure to parallel the three funding levels. Made consistent to funding levels of \$1-\$40,000, \$40,001 – \$75,000 and \$75,001 to \$150,000. (Previously we had 1-40,000, 40,001 – 100,000 and 100,001 to 150,000 in match requirements, which did not match up with 3 funding levels.)
12. Other verbiage incorporated to match general contents, same as Cultural Facilities, wherever appropriate to both programs (i.e., insurance, records retention, etc.)
13. Applications submitted become property of Orange County Arts & Cultural Affairs and may be distributed to the public upon request, or as examples.
