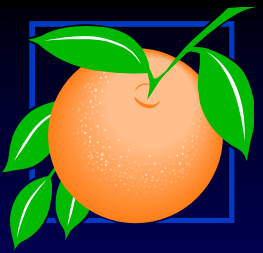




# Vivitrol Pilot Program Background

- **Orange County Heroin Task Force convened - August 2015**
  
- **Heroin Related Deaths**
  - **2015 – 85**
  - **2016 – 66 Heroin**  
**68 Fentanyl**  
**22 Fentanyl Analogs**
  
- **Jail Vivitrol Pilot Program**

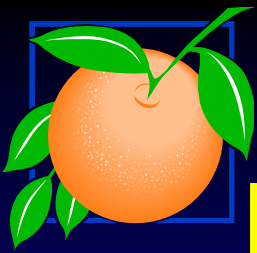




# Vivitrol Pilot Program Statistics

- **In 2015, of 43,134 inmates booked into the Orange County Jail, approximately 2000 were dependent/addicted to heroin.**
- **In 2016, of 38,078 inmates booked into the Orange County Jail, approximately 2072 were dependent/addicted to heroin.**

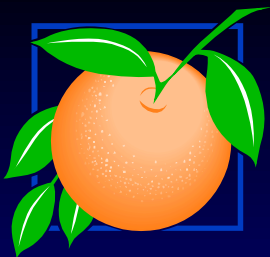




# **Vivitrol Pilot Program Implementation**

- **Subcommittee – November 2015**
- **Pilot program began on June 13, 2016**
- **Funding - Department of Justice Byrne Grant**
- **Paths**
  - **Treatment with Vivitrol®**
  - **Narcan®**
  - **No interest**



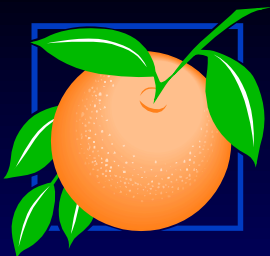


# Vivitrol Pilot Program Program Data

- **4,821 Heroin users identified**
  - **953 screened for interest**
  - **92 qualified for treatment**
  - **36 received Vivitrol (27 injections, 9 oral)**
  - **404 given Narcan at discharge from jail**



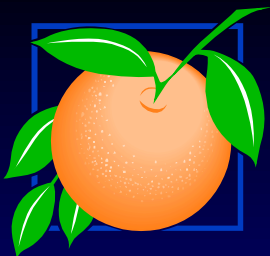

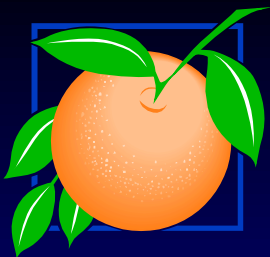

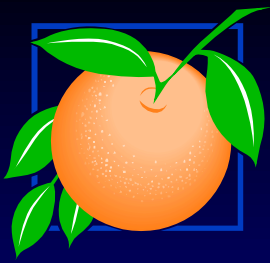




# Residential Substance Abuse Treatment Program (RSAT)

- **After-Care Upon Release**

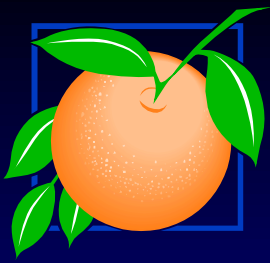




# Choices Program

- **Child Support Assistance**

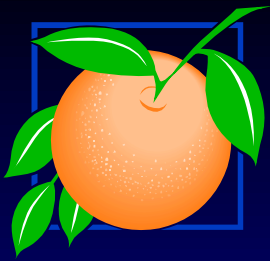

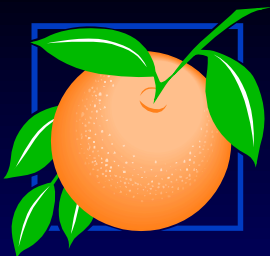
