# WHAT IS THE HOUSING CHOICE VOUCHER (HCV-SECTION 8) PROGRAM?

The Section 8 program is a subsidized rental assistance program for extremely low income families. The amount of the monthly rental subsidy will be based on the gross monthly household income of the applicant. The Orange County Housing and Community Development Division will be accepting pre-applications to establish a waiting list of eligible applicants for assistance under the Section 8 Program.

#### **HOW DO I APPLY?**

You must complete a pre-application which will only be available on-line at www.ocfl.net/waitinglist On-line pre-applications will be accepted during the application period from September 24, 2012 at 12:01 a.m. and will end on October 3, 2012 at 11:59 p.m. Once you have successfully completed the pre-application you will be provided an application number. When the application period closes, a computerized random lottery will be conducted to establish a waiting list of up to 850 applicants. Once the lottery has been completed, we will contact all applicants to inform them of the status of their pre-application. Hand delivered or mail delivered preapplications will not be accepted, only on-line pre-applications will be accepted. Households submitting more than one pre-application will be disqualified.

## WHO IS ELIGIBLE?

1. If your gross household income (before deductions) is less than or equal to the amount indicated below for your household size, you're eligible to apply for assistance under this program.
