FINAL DESIGN UNDERWAY


Orange County has initiated the design phase for four general use lanes, two transit lanes, and a truck staging lane for Tradeshow Boulevard from Destination Parkway to Universal Boulevard, a distance of 0.66 miles.

This project will be designed in general accordance with the Tradeshow Boulevard Roadway Conceptual Analysis completed in August 2021, which evaluated alternatives for expanding capacity and improving transit connectivity along the corridor. The construction plans are scheduled to be completed in early 2024. The project team will issue a series of newsletters and the website will be updated as necessary.

PROJECT DETAILS


The proposed design includes two 11-foot-wide travel lanes in each direction separated by a raised median. The widened roadway will also have two 12-foot-wide transit lanes and a truck staging lane. A 10-foot-wide shared-use path will be provided on both sides of the road for pedestrians and bicyclists. The project also plans to incorporate drainage improvements, lighting, landscaping, and signalization. Right-of-way acquisition will be needed for the roadway and stormwater improvements.
