

**PUBLIC NOTICE**  
**AMENDMENT TO ORANGE COUNTY CITIZEN PARTICIPATION PLAN**  
**SUBSTANTIAL AMENDMENT TO 2019-2020 ONE-YEAR ACTION PLAN**

Notice is hereby given that, in accordance with 24 CFR 91.105(c)(2) of the federal regulations relative to citizen participation for Community Planning and Development Programs and applicable waivers made available to those requirements through the Coronavirus Aid, Relief, and Economic Security (CARES) Act, which was signed into law on March 27, 2020, Orange County is making a substantial amendment to the 2019-2020 One-Year Action Plan and an amendment to its Citizen Participation Plan available to the public through this notice. The Action Plan is a component of the 2016-2020 Orange County Consolidated Plan, a strategic plan covering five federal fiscal years that identifies the County's housing and community development objectives and priorities. Both amendments are available for a 5-day public review and comment period from June 15, 2020 to June 19, 2020.

These amendments will enable the County to receive and administer the funding from Department of Housing and Community Development (HUD). The amendment to the Citizen Participation Plan will allow for a reduced public comment period of no less than five (5) days and for virtual meetings as a method of citizen participation during a declared disaster or a health-related emergency event, such as the coronavirus (COVID-19) pandemic. The substantial amendment to the 2019-2020 One-Year Action Plan incorporates supplemental funding received under the CARES Act and outlines a list of activities to be undertaken with those funds to prevent, prepare for, and respond to the COVID-19 pandemic. The proposed budget for the substantial amendment includes funding from the supplemental Community Development Block Grant (CDBG-CV) Program for the sum of \$4,147,196 and the supplemental Emergency Solutions Grant (ESG-CV) for the sum of \$2,024,224, as well as the projects and activities that will be implemented using these funds.

Additional funding made available to Orange County by HUD through the CARES Act is unknown at this time but will be used for the same purpose of the initial allocations indicated above, which is to prevent, prepare for, and respond to the COVID-19 pandemic by facilitating assistance to eligible communities, households, and persons impacted by COVID-19. A list of proposed activities to be funded with the additional funds is provided below.
