

Conditions of Permit

- 1. The applicant shall have a site inspection and approval by the Orange County Fire Rescue Department prior to conducting a event.
- 2. The applicant shall comply with all applicable requirements of the Florida Statutes, the State Fire Marshal's Rules and Regulations, the Florida Fire Prevention Code, and all other applicable codes and standards.
- 3. The authority having jurisdiction shall require standby fire personnel when potentially hazardous conditions exist, due to the type of performance, display, exhibit, or activity, or the number of persons present (FFPC 3-10.3). The number of personnel and fire department apparatus shall be determined by the Fire Marshal after review of the specifics of the event.

I hereby certify that I have read this application and that all information contained herein is true and correct to the best of my knowledge. I certify that I am authorized by the organization named herein to act as its agent for the herein-described activity. - Fire watch request letter. (Must include brush truck request if needed)
- Planning and use coordinated with the venue manager, owner, or homeowners association
- □ Name of the person, group, or organization sponsoring the production
- D Evidence of the permit applicant insurance carrier or financial responsibility
- Provide a descriptive narrative of the event.
- Provide a detailed site plan showing: Fallouts, Audience & Product Location
- Determine that measures are established to provide crowd management, security, fire protection, and other emergency services
- Provide Material Data Safety Sheet (MSDS)
- Pyrotechnics Only: Qualifications and identification of pyrotechnics operator and assistants

Permit Fee of \$371 for Aerial Fireworks/Pyrotechnics/Flame Effect* is not refundable. Permit Fee of \$105 Open Flame is not refundable.

*Includes permit, permit review, and inspection when set-up. Hourly fire-watch and stand-by fees are in addition and are charged 1 hour prior to the shoot time, until 1 hour after the final shot, with a four hour minimum. Applications must be submitted 21 days prior to the shoot or an expedited plans review fee of \$261 will be charged.
