Orange County Government received \$219 million in federal disaster recovery funding (CDBG-DR funds) to help communities in hard-hit areas recover from Hurricane Ian. Orange County aims to provide our residents and community partners with the most up to date information as the County moves forward with its implementation of the CDBG-DR programs.

To achieve this, a monthly newsletter containing the latest CDBG-DR program updates will be released on the last calendar day of each month. We encourage you to share this newsletter with your friends, family, colleagues, and anyone else who, you believe, might benefit from this information. This month, we are focusing on the CDBG-DR Infrastructure and Public Facilities program.

**Shalima Banks** joined Orange County as the Business Unit Financial Advisor for the CDBG-DR team in June of 2024. She has an extensive background in corporate Finance, and has a Bachelor's in Finance from UCF, and an MBA from Stetson University.

**Demetri Santiago** joined Orange County as a Student Intern in September of 2023. He then joined as a Senior Fiscal Coordinator in May 2024, after successful graduating from the University of Central Florida with a Bachelor's in Accounting.

## Infrastructure and Public Facilities Updates

Orange County is preparing to roll out the CDBG-DR Infrastructure and Public Facilities program through a competitive Request for Applications (RFA) process. With an allocation of **\$59,322,240** (27% of the total allocation), and an additional set-aside of **\$28,658,000** for mitigation projects and activities, this initiative aims to address unmet needs from Hurricane Ian by funding critical Infrastructure and Public Facilities projects, such as flood and drainage improvements, storm water management projects, restoration of damaged infrastructure, and rehabilitation of public facilities.

The maximum award per project is \$15,000,000.

Additionally, to meet the program eligibility requirements, the proposed projects must:

- Benefit the broader Orange County community (to include historically underserved neighborhoods);

- Adhere to federal regulations, including requirements for long-term resilience and disaster tie-back (note: tie-back to Hurricane Ian is not required for mitigation projects).

The first round of applications will be open to Orange County Departments and Divisions and local municipalities. Another round of applications for non-profit agencies will be announced at a later date.


Additionally, the County is currently drafting the Policies and Procedures for this program, which will be made available on the County's CDBG-DR website once finalized. The Notice of Funding Availability (NOFA) is expected to be published by mid-September 2024 and will include detailed information about the program, application process, project evaluation criteria, and pre-award technical assistance workshop(s). Pre-award technical assistance will be provided to help applicants better understand eligibility and navigate the application process, with specific workshop details included in the NOFA. Orange County staff will be conducting a direct outreach to its municipal partners to inform them of the upcoming funding opportunity. All applications received will be reviewed and scored, with notifications sent to applicants regarding their project's approval status.

The County emphasized the importance of stakeholder involvement and provided multiple opportunities for public input throughout the planning process.

- **January 9, 2024:** BCC public hearing for the CDBG-DR Action Plan. Please click [HERE](#) to view the public hearing recording.
- **January 17, 2024:** Orange County submitted the final CDBG-DR Action Plan to HUD for review and approval. Please click [HERE](#) for the final CDBG-DR Action Plan.

- **June 17, 2024:** Orange County CDBG-DR Final Public and DRGR Action Plan was reviewed and approved by HUD.
- **Summer 2024:** Program policies and procedures are being developed for the Infrastructure & Public facilities program.
- **Late September 2024 (Tentative):** Notice of Funding Availability will be posted for the CDBG-DR Infrastructure & Public Facilities program (first round of funding – for local jurisdictions and County departments and divisions); Pre-Award Technical Assistance workshop will be held on the RFA process.
- **October 2024 (Tentative):** Request for Applications (RFA) for Infrastructure & Public Facilities program to open for local jurisdictions and Orange County.
- **Late 2024/Early 2025 (Tentative):** Agreements for the approved Infrastructure & Public Facilities projects will be issued.
- **Early 2025 (Tentative):** 2nd RFA under the Infrastructure and Public Facilities Program to open for non-profits organizations.
