Community Updates

Code Compliance

Cheryl Rayburn shared the following:

- The county still has a contract with a company to pick up snipe signs throughout the county as well as the code compliance officers.
- Seems like this sentence was out of nowhere and add a transition phrase - There were also items dumped out on the sidewalk.
- During tax season typically there are more snipe signs.
- Resident (should we remove her name based on public record?) Jessie Norman asked about illegal parking and whether code enforcement comes into her neighborhood. Cheryl advised ~~to~~ her to call 311 to file her complaint and they will investigate the claim. Resident voiced her concerns about the complainant's information is being shared.
- Dr. Latanya Nichols stated that she picks up signs when she sees them on the road. She also asked fines can be imposed for the businesses that puts out the snipe signs. Cheryl will follow up with management regarding potential solutions.
- Chair Michael - in the past the PHNID had a technician on staff and Tamara shared that the position has been posted and we look forward to bringing someone aboard to help with keeping the PHNID clean.

OCSO

Lt. Kelly Burda stated there is a rise in auto burglaries:

- 28 out of 49 cases had unlocked doors.
- 4 of the unlocked doors had stolen firearms as well.
- Residential burglaries for new construction and renovated houses are also increasing.
- She encourages individuals to call 911 if they see suspicious trucks, vans and moving vehicles in the areas
- Anonymous tips will typically get handled ~~last~~ after priority/emergency calls. Lock doors and don't leave spare keys in cars. Public Safety numbers are trending down currently.

NID Staff Update (Tamara Johnson)

- Lunch and Learn was a success with 10 partners.
- Attendees participated in 4 mini workshops (attire, barriers to employment, interview skills, and resume' building).

- Panel discussion from “The Experts” (Coca-Cola, Hardees, and Orange County Human Resources) regarding what hiring managers will look for when deciding on a potential job candidate.
- Septic to Sewer is underway on Pine Hills Road.
- Lynx Super Station is slated to be completed in April.
- The knee wall correction will begin soon and will read Pine Hills Est. 1952.
- PHNID met with Urban Land Institute (ULI) concerning the opportunity to receive a Main Street Designation. She will share the outcome once it is received.
- PHNID cleanup in partnership with Evans High school is April 26th.
- Onetha Mason asked if the residential Septic to Sewer applications are still being accepted. Tamara will provide contact information for Alivn Cruz to answer this question
- Dr. Nichols asked about how we envision the corridor from growth perspective. It was shared that The vision is a Town Center. One of the caveats is that investors usually want sewer lines and not septic. We would also need to look into an anchor store/business.
- Small Business Week is the first week of May.

Presentation

Nicholas Taylor provided an overview of STEPS. The program houses residents who are in need of treatment for substance abuse. The program consists of outpatient, residential, and day treatments. The residential program provides transportation to appointments (doctor, parole, etc.). STEPS also assists with mental health so that participants can gain and maintain their jobs. The Comprehensive Needs of Fathers assists fathers with court and what else?. STEPS also has a mobile unit that goes out and help residents with their needs as part of the Care Coordination program. The Medication Assisted Treatment has a community clinic. STEPS also provides HIV testing.
