All applications must comply with the requirements outlined in Section 15-301and include a Tree Survey completed by a professional surveyor, as defined by Section 15-277, of all Regulated Trees 8" DBH (Diameter at Breast Height) and greater (per Section 24-12(a)), Specimen trees (per Section 15-283(a)), and Heritage trees (per Section 15-283(b)), with this application. Once the application is processed you will be sent an application number and will be able to pay online through Fast Track.

An Arborist within the Zoning Division will review the application for compliance with the code. Additional reviews will be required by the Orange County Environmental Protection and Development Engineering Divisions. Allow up to 14 days for a complete review of the application. Be aware that if other departmental reviews are necessary, additional review fees will apply and will be due upon permit issuance. If approved, the permit will be valid for 60 days from that date of issuance.

Please submit your application online through Fast Track where you can also track the status of the application.
