



Avalon Road (CR545) Town Center West PRELIMINARY DESIGN STUDY

Orange County Transportation Planning Division is conducting a Preliminary Design Study (PDS) to evaluate the addition of travel lanes to the existing two-lane sections of CR545 (Avalon Road) from Schofield Road to McKinney Road, a distance of approximately 1.8 miles.

The PDS is Orange County's detailed project development process used to evaluate potential roadway improvement options and address anticipated mobility needs of the corridor. In addition, the study will assess both social and environmental impacts associated with the planned road improvement. The proposed improvements are intended to enhance traffic flow and safety in the area.

PUBLIC MEETING SCHEDULED

An open house will be held from 5:45 to 6 p.m. The meeting will begin with a formal presentation at 6 p.m. followed by a question-and-answer forum. Orange County staff and members of the Study Team will be available to discuss the project and answer questions.

The meeting is being conducted to present the preferred alternative roadway improvement. This meeting will give you the opportunity to provide input and express your interests and concerns regarding the roadway improvements.

WAYS TO STAY INFORMED


