## Overall Progress Narrative:

During the fourth quarter of 2025, Orange County continued advancing the Community Development Block Grant-Disaster Recovery (CDBG-DR) program for recovery from Hurricane Milton. HUD approved the County’s Action Plan on July 3, 2025, and the Grant Agreement was executed on July 22, 2025, formally securing federal funding to support long-term recovery and resilience efforts.

Earlier program development activities established the administrative framework necessary for implementation. On November 19, 2024, the Orange County Board of County Commissioners (BCC) approved a contract with Horne LLP to provide grant management services and to administer the Orange County Recovers program. On January 16, 2025, HUD allocated \$33,357,000 in CDBG-DR funding for Hurricane Milton recovery. To incorporate these funds and ensure continuity of program administration, the Housing & Community Development Division sought and received BCC approval on November 18, 2025, to amend the existing Horne LLP contract.

Following these actions, Orange County initiated updates to program policies and procedures for Infrastructure, Public Facilities, Mitigation, and Planning activities to ensure alignment with Hurricane Milton requirements and HUD regulations. These activities focused on establishing compliance frameworks, procurement procedures, risk mitigation strategies, and coordination protocols with subrecipients and partner agencies. Program launches for these activities are anticipated in early 2026, with implementation updates provided as progress continues.

Planned activities for the next reporting quarter include the continuation of community outreach efforts beginning in early 2026. These outreach events will support the Orange County Recovers program with a targeted focus on homeowners experiencing unmet needs and unrepaired damage resulting from Hurricane Milton (October 2024). Outreach efforts are intended to ensure equitable access to assistance, increase program awareness, and support eligible households throughout the application and recovery process.

Throughout the quarter, the County prioritized outreach, partner capacity building, and the development of robust procurement and compliance procedures to mitigate risk and support the timely, compliant use of CDBG-DR funds. Conclusion:

Orange County made measurable progress during the fourth quarter of 2025 in establishing the administrative, policy, and compliance foundations for the Hurricane Milton CDBG-DR program. With key approvals secured and program frameworks in place, the County is positioned to begin program implementation in early 2026 and to advance long-term recovery efforts for residents impacted by Hurricane Milton.

Activity Progress Narrative:

During the fourth quarter of 2025, Orange County advanced planning efforts under the CDBG-DR Hurricane Milton allocation to support long-term recovery and resiliency planning. A total of \$200,000 (1 percent of the grant allocation) has been designated for Planning activities. Planning funds will be made available to Orange County departments and divisions, as well as municipal governments, to support studies, analyses, and other planning efforts that may inform additional recovery and

resiliency priorities, enhance program design, or support implementation of the County's CDBG-DR programs. Eligible activities also include updates to the Unmet Needs Assessment and other components of the CDBG-DR Action Plan, as needed. During the reporting period, the County began preparing a activities to solicit Planning Study proposals, which is anticipated to be released in the next reporting quarter. Expenditures associated with this activity are expected to be reprogrammed/moved to specific planning projects and activities once project selection is completed. Additional updates on Planning activities will be reported in future quarters as implementation progresses.
